Content Provider will, upon request of Producer, provide documentation to demonstrate such rights. - Responsibilities.** If a third party brings a legal claim against Producer regarding the Content, then Content Provider will defend and indemnify Producer in connection with any such legal claim.
- Compensation.** Producer will pay to Content Provider the amount of Compensation (if any) set forth above. If no amount is listed above, or \$0 is listed, Producer will have no obligation to pay any amounts to Content Provider.
- General.** If any court finds any portion of any provision of these terms to be unenforceable, that portion will be deemed modified to the least extent necessary to make it enforceable. These terms are governed by Florida law. Any dispute must be brought in a Florida court. These terms are the entire agreement between the parties with respect to its subject matter.
